

TERMS and CONDITIONS

1. **Promotion Duration:** The promotion commences at 00.01 am on the:

2. Eligibility to enter:

- The eligibility for the draw is determined by the system time, specifically the local time in Samoan time, rather than the customer's phone time.
- The promotion is open only to legal residents of Samoa aged 21 years and over ("Eligible Entrants") and excludes tourists visiting the country.
- Vodafone Prepaid & Post-paid Capped Mobile users, and Prepaid & Capped Fixed Line users are eligible for this promotion Both New and Existing.

4. Drawing of Entries & Prizes:
