By entering this promotion, participants accept these terms and conditions. Entry into the promotion constitutes acceptance of these rules. All times are local to Samoa. Headings are for convenience only and do not affect interpretation.

Promotion Details:

- **Promotion Launch Date:** 10th November 2024
- **Promotion End Date:** 4th January 2025
- **Promotion Duration:** 2 Months
- **GCA License:** SPC048/2024

Entry Point:

1. Purchase any mobile prepaid bundle value at \$15 or more.
2. Purchase any device from any Vodafone outline or Vodafone online shop.

Eligibility:

1. Open to legal residents of Samoa aged 21 and over.
2. Tourists visiting Samoa and Vodafone staff or their immediate families on Vodafone benefits are ineligible.
3. New and existing Vodafone mobile prepaid & postpaid-capped users.
4. All new and existing customers that buy a mobile device from Vodafone stores or online shop.

Entry Requirements:

- New and existing Vodafone mobile prepaid and postpaid customers are eligible.
- Qualifying purchases:
 - Mobile prepaid bundles of \$15 or more earn entry points.
 - Device purchases (cash and finance sales only) from any Vodafone store.
 - Postpaid Corporate contract customers qualify when paying in cash or financing devices (credit sales do not qualify).
- Earn 1 entry point per tala spent (e.g., a \$15 bundle purchase = 15 points).
- Entries reset at the close of each fortnightly draw, but all entries from previous periods will carry over for the Major Prize Draw (F4).

Prize Draws & Winner Verification:

- Fortnightly Draws: Entries reset every two weeks, and draws are conducted using a random selection tool (random.org) in the presence of a GCA representative.

- Winners will be drawn randomly and contacted via the mobile number provided for verification.
- Winners must present valid identification for prize collection and will forfeit the prize if suitable proof is not provided.
- If a winner cannot be contacted after three attempts, or eligibility is not met, a redraw will occur under GCA supervision.

The major prize winner is responsible for obtaining necessary travel documents, including a valid passport and visa where applicable. Prizes will be awarded upon identity verification through both phone number confirmation and valid ID presentation.

- Customers will receive confirmation of their entry points by text message.
- To check entries, customers may text "JAPAN" to short code "106" (zero-rated) or call Customer Care at 121 / 67121.
- Winners will be notified by phone and scheduled for prize collection within 1 business day after verification.

The Promoter reserves the right to use the name, photograph, voice, or video of the winner for promotional purposes without additional compensation.

Right to Redraw:

The Promoter may redraw in cases where a winner does not meet eligibility requirements, forfeits, or does not claim the prize.
